#### **ARENA RIDING PASSES:**

**\*\*\*Riding pass holders must be a member of CDAS. Riding passes are based on a calendar year. A riding pass enables the holder use of certain arenas at any time it is not previously booked by commercial rentals or user groups. Refer to Calendar of Events on website to see when arenas are available.**

**\*\*\*Riding passes may have previous years volunteer hours applied to them. This must be approved by CDAS.**

Couple Riding Passes include common law, spouse, brother, sister etc. as long as they are living at same residence.

Family Riding Passes include common law, spouse & all children regardless of age as long as they are living at same residence.

Any BREACH of CDAS policies & procedures may result in loss of facility privileges

#### **CROSS COUNTRY COURSE RIDING PASSES:**

RP XC 2009 season \$190.00

**XC course riding pass holders must be a member of CDAS. Riding passes are based on a calendar year. A XC riding pass enables the holder use of cross country course at any time it is not previously booked by commercial rentals or user groups.**

**XC course riding pass holder must schedule their use at least 4 days in advance and must be accompanied by a CDAS recognized instructor.**

#### **CDAS INSTRUCTORS: \$75 per year plus \$15 membership**

**Any/all instructors using any portion of CDAS grounds for monetary compensation must: 1. Be a CDAS member, 2. Be a registered instructor with CDAS, 3. Pay above fees and provide proof of liability insurance.**

**Use of arenas for instructional time must be booked at the commercial rates.**

#### **USER GROUPS: User Groups are CDAS annually approved committees of CDAS**

**(all members of user groups must be member of the CDAS & have paid ground use fees below)**

**Grounds Use Fees can be deducted from appropriate riding passes only after paid through User Group Membership**

<b>Indoor Arena</b>	50% hourly rate maximum of \$220 per day
<b>Outdoor #1 Arena</b>	50% hourly rate maximum of \$165 per day
<b>Outdoor #2 Arena</b>	50% hourly rate maximum of \$165 per day
<b>Multiple Arenas</b>	50% combined hourly rate maximum of \$357.50 per day
<b>Stalls</b>	75% of current rate per stall per day

**User groups are subject to bumping for commercial rentals with right of first refusal given to the USER GROUP to pay commercial rate to hold bookings.**

**Cross Country Course fees are waived only for User Group Members under the age of 25.**

**Each User group is responsible for all set up, tear down & clean up after each use. In the event tear down & clean up are not performed by user group a fee will be charged at sole discretion of CDAS (MINIMUM FEE \$50).**
